In June 2011, plaintiffs advised the Court that the claims administrator, Gilardi & Co. LLC ("Gilardi"), anticipated that the claims administration process would be complete on or about December 12, 2011. Plaintiffs' Status Conference Report at 8, filed June 10, 2011 [Dkt. No. 1766]. The claims administrator has been working diligently to complete the claims process by that date. However, due to ongoing quality assurance testing and audit work, the claims administrator now anticipates the process will not be completed until December 22, 2011. On December 22, Gilardi expects to provide the Court with a final report identifying the class members, and each class member's allowed loss as calculated by the claims administrator pursuant to the Court's plan of allocation.

The claims process is now in its final stages. The claims administrator, as of today's date, has identified approximately 46,133 claims with an allowed loss that are viewed as valid, subject to Gilardi's final review. The total allowed loss, as calculated by Gilardi, currently exceeds \$2.24 billion.

With the permission of the Court, plaintiffs anticipate filing under seal any portions of the claims administrator's final report which identify account information, loss amounts or any other confidential information.
