In its Order dated February 3, 2012, this Court indicated that Lead Counsel for the Class may

submit, for the Court's review and approval, a proposed notice: (a) advising the Class of Lead

Counsel's intention to file an application for approval of fees and expenses and reimbursement of the

expenses incurred by Lead Plaintiffs in representing the class; and (b) advising all claimants who

have received rejection letters from the claims administrator that their claims will be rejected absent

further order of this Court. Lead Plaintiffs and defendants met and conferred regarding the proposed

language and timing of a proposed notice. Based in part on those discussions and in part on the fact

that certain critical issues may be resolved by the April 20, 2012 status conference, Lead Counsel for

Plaintiffs has decided to defer the submission of a proposed notice to a later date. Defendants have

no objection to Lead Counsel's decision.

Lead Counsel for Plaintiffs anticipates raising the proposed notice with the Court again at the

hearing on April 20, 2012. At that point, more information will be available regarding the status of

the case and the notice can, therefore, be more informative. If the Court would prefer to address this

issue before the April 20 hearing, Lead Plaintiffs are available at the Court's convenience.
