

Sir:

I received on August 6, 2011 a request for supplemental documents to my original submission, which you received on April 28, 2011. On August 15, 2011 I mailed a reply with the supporting documents that you requested. The package of my letter and the supporting documents was accepted by your firm on August 18, 2011.

The claim and documentation that I filed was almost identical to that filed by my brother, Robert D. Sheap. We both acquired the same number of shares (1254 shares) at the same time, as explained by my letter of August 15, 2011 (attached). Our shares were held in separate accounts. Robert Sheap called me in December 2011 telling me that he had received a note from your office that his case had been reexamined and was a valid claim.

I called your office on December 9, 2011 at 3:30 p.m. and talked to Ana (or Anna) at 3:39 p.m.EST. She put me on hold while she looked up my file and talked to someone else in the office. She came back on the phone and said that my claim also had been reviewed and "was good". I did not receive any follow-up paperwork from Gilardi & Co. I was not concerned because I was led to believe that my claim was good.

On February 13, 2013 I felt that I had waited enough. Robert Sheap indicated that he had heard nothing since his letter from you in 2011. I followed up with a call again to your office at 2:18p.m.EST. Again I spoke to Ana at 2:18 p.m. who checked the list again and reassured me that my claim was still on the list of those accepted. She said that the matter was still before the judge, who had not made a decision. She also said that the process is long and that the judge's decision could be appealed.

On Friday, December 6, 2013 I received a call from Robert Sheap that he had received from the court a list of those claims that had been accepted. His claim, identical to mine, was accepted. My claim number was not on that list. I called Gilardi on Monday, December 9, at 5:45 EST. Again I got Ana. She said that my claim was valid and that Gilardi was still reviewing claims. I asked her to send me a confirmation. I have received nothing as of December 16, 2013.

OnFriday, December 13, 2013 at 2:47 EST I called the Gilardi office again and spoke to Shara. I asked to speak to a supervisor. Shara said that she checked with her supervisor and that everyone dealing with the claim who was a decision maker had gone home.

This letter is to request documentation from you confirming that my claim was accepted. If my claim was not accepted, I request the reason for your decision. My documentation to you was complete. I feel that there must have been a clerical error in not including me on the list of those who qualified for the settlement.
