THIRD SUPPLEMENTAL DECLARATION OF MICHAEL J. DOWD IN FURTHER SUPPORT OF MOTION FOR AN AWARD OF EXPENSES

I, MICHAEL J. DOWD, declare as follows:

- 1. I am a member of the Firm of Robbins Geller Rudman & Dowd LLP ("Robbins Geller" or the "Firm"). I am submitting this declaration in further support of Plaintiffs' Motion for an Award of Expenses.
- 2. The Firm is counsel of record for Lead Plaintiffs Glickenhaus & Co., PACE Industry Union-Management Pension Fund, International Union of Operating Engineers Local No. 132 Pension Plan, and the plaintiff Class.
- 3. I have previously submitted three declarations in support of the Firm's request for an award of charges and out-of-pocket expenses. *See* Dkt. Nos. 1964, 2225 and 2254. At the final approval hearing on October 20, 2016, this Court requested additional information regarding a category of expenses entitled "Meals, Hotels and Transportation: \$1,194,944.35." In response, we submitted additional information on October 27, 2016. On November 1, 2016, this Court entered an order regarding that request for expenses.
 - 4. In response, we have taken the following steps:
- (a) Meals: We have decided not to seek reimbursement of any meal expenses.

 Although these are actual out-of-pocket expenditures, we decided to pass this savings along to the Class;
- (b) Hotels: We have reduced our hotel expenses to the Government per diem amounts for the time periods and cities/counties in effect at the time the charge was incurred. As to the rare instances where the original expense reimbursement request that we sought for a given hotel stay was lower than the Government per diem amount, we used the lower, actual amount. However, we note that, as a private law firm, we do not qualify for the "Government Rate" at hotels. Obviously, if we were permitted to use the Government Rate, it would result in enormous savings. For example, on November 4, 2016, I went on the website for two Marriott hotels, one in Chicago and one in New York, to determine the difference between amounts paid by regular travelers (like our firm) and Government travelers. I looked for rooms for the evening of December 8, 2016 using both the rate quoted for Government employees and the rate quoted for non-Government guests. On

December 8, 2016, Government travelers are quoted a price of \$137 per night at the JW Marriott in Chicago. This quote coincides with the Government per diem rate for hotels in Chicago on that date, which is also \$137 per night. The rate for non-Government travelers (who are members of AAA) to stay at the JW Marriott on December 8, 2016 is \$299 per night. Similarly, the Marriott Marquis in Manhattan quoted a Government Rate of \$301 per night (plus \$47.89 in taxes). Again, it precisely coincides with the Government per diem rate of \$301 per night. The AAA rate for non-Government employees on that same night, including taxes will be \$601.35. Although the Government rates are not available to us, pursuant to the Court's November 1, 2016 Order, we will seek to be reimbursed at the Government per diem rate. The amount sought is set forth in Exhibit 1;

- (c) Short Term Apartment Rentals: We have also included a column in Exhibit 1 that reflects the amounts expended for short-term apartment rentals during the 2009 trial and for the time that we were in Chicago preparing for the 2016 trial; and
- (d) Transportation: Pursuant to the November 1 Order, we went back through our expenses to segregate airfare from ground transportation, which primarily consisted of cab fares. We will not seek reimbursement for any ground transportation and will pass those savings on to the Class. After removing the ground transportation charges, I again reviewed the airfare charges and made additional judgmental reductions to many of those charges. The net effect is that I made an additional judgmental reduction of \$22,073.65 from the airfare out-of-pocket expenses. The airfare expenses, as reduced both through our normal procedures and this further reduction, are also set forth in Exhibit 1.
