1. Lead plaintiffs and the Class respectfully move this Court for an order compelling defendants to produce responsive documents to Request Nos. 1-2, 6, 9-13, 16, 24, 27, 30 and 35 of the Class' Third [Corrected] Request for Production of Documents ("Third Request").
